2) No Amendment to the Memorandum of Association of trust shall be made which may Prove to be repugnant to the Provisions of section 2(15), 11, 12, 13 and 80(g) of the Income Tax Act. If any amendment is to be made the same should be made with the prior approval of the Commissioner- Income Tax.

3) In the event of Dissolution or Winding up of the Trust the Assets remaining on the said date shall under no circumstances be distributed among the Trustees, but the same shall be transferred to any other Educational, Charitable, or Cultural Trust whose objects are similar to this Trust.
